About this Report

As part of its participation in The National Citizen Survey™, the City of Englewood conducted a mailed survey of 1,500 residents. Surveys were mailed to randomly selected households in January 2018 and data were collected through February 26, 2018. After the official data collection period was underway (see the report, *The National Citizen Survey: Community Livability Report, Englewood, CO, 2018*), the City made available a web-based survey to its residents through a link on the City's website. Visitors to the site were able to complete the survey during February and early March 2018 and 375 surveys were completed.

This report contains the results of this administration of the additional web-based survey. These data have not been weighted to current population estimates of Englewood.
