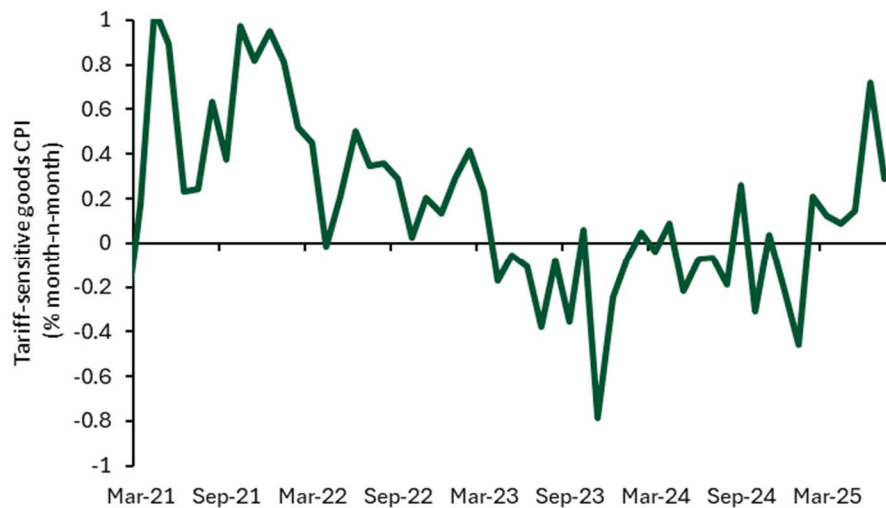

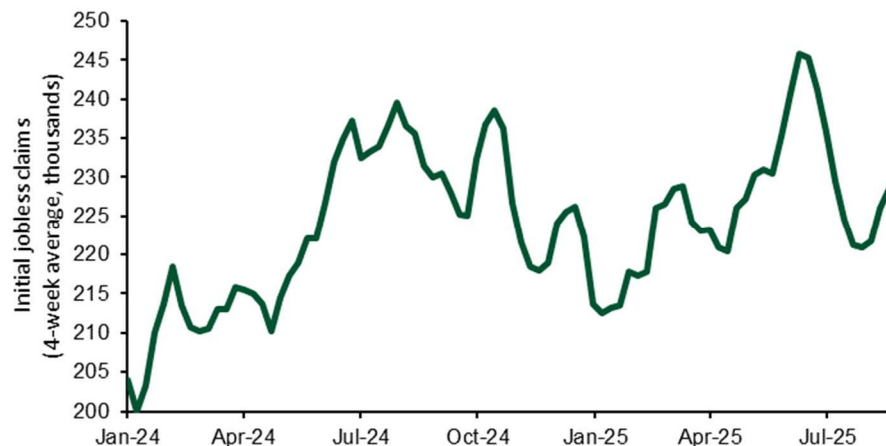

Economic Indicators and Monetary Policy

On the trade front, the White House announced new 25% tariff rates on India as retaliation for purchasing Russian oil. It also extended steel and aluminum tariffs to additional “derivative products” like aerosol cans. The US also further extended its pause on tariffs against China for another 90 days (until November 10). Elsewhere, Canada dropped some retaliatory tariffs against the US, but kept them in place for products like steel, aluminum and autos.

The second estimate of Q2 GDP growth was revised up from 3% to 3.3% SAAR, which reflected upward revisions to consumption and business investment (in areas likely driven by AI-related spending). Real final sales to private domestic purchases (a metric of the report closely watched by the Fed as a proxy for consumer strength) was revised up from 1.2% to 1.9%, the same as the previous quarter.

Regarding inflation, headline CPI remained at 2.7% and headline PCE remained at 2.6%. Core CPI rose from 2.9% to 3.1% while Core PCE increased from 2.8% to 2.9%. Tariff-related inflation actually eased modestly but some inflation in core services kept core inflation elevated.

The US economy added 73,000 new jobs in July, with services job gains still concentrated in healthcare. The main headline, however, was an unexpectedly large 258,000 in downward revisions to the prior two months, which prompted President Trump to dismiss the head of the Bureau of Labor Statistics, Erika McEntarfer. The unemployment rate increased to 4.2% from 4.1% while the participation rate fell from 62.3% to 62.2%. Elsewhere, the 4-week average of initial jobless claims rose from 221,000 to 228,000 over the month, albeit it may have been subject to residual seasonality. Continuing claims remained around cycle highs.

At the annual Jackson Hole symposium, Fed Chair Powell emphasized “the balance of risks appears to be shifting.” By the end of the month, markets moved to price in an 88% probability of the rate cut at the next FOMC meeting.

Interest Rate Summary

Equities continued to rally but credit spreads widened. Front-end Treasury yields fell as markets reflecting a higher probability of imminent rate cuts. At the end of August, the 3-month US Treasury bill yielded 4.14%, the 6-month US Treasury bill yielded 3.96%, the 2-year US Treasury note yielded 3.62%, the 5-year US Treasury note yielded 3.7% and the 10-year US Treasury note yielded 4.23%.

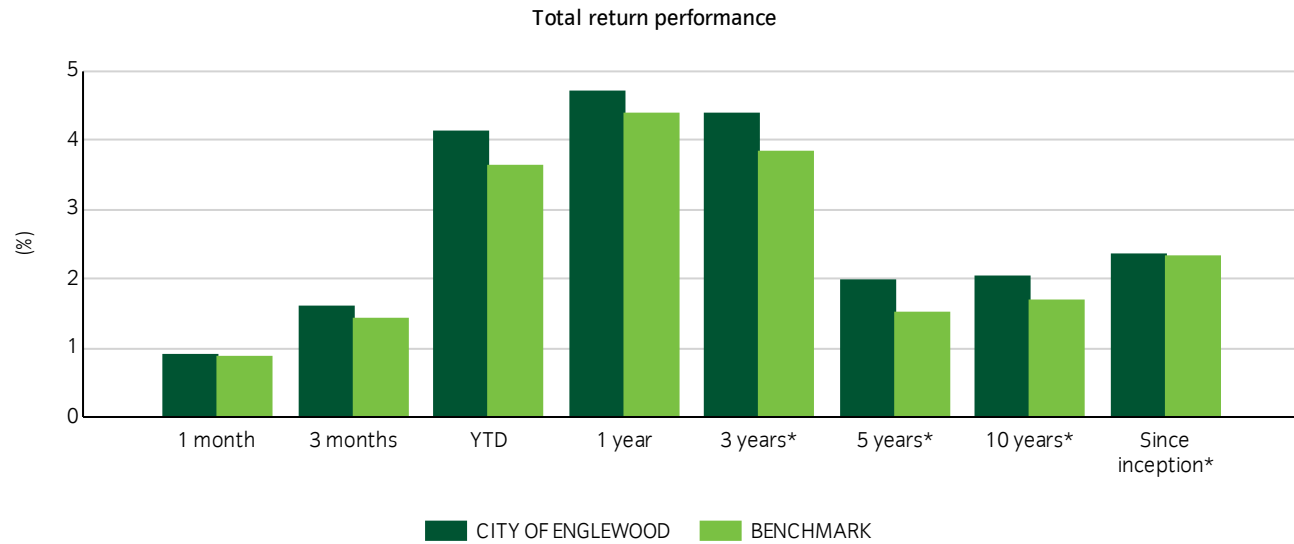

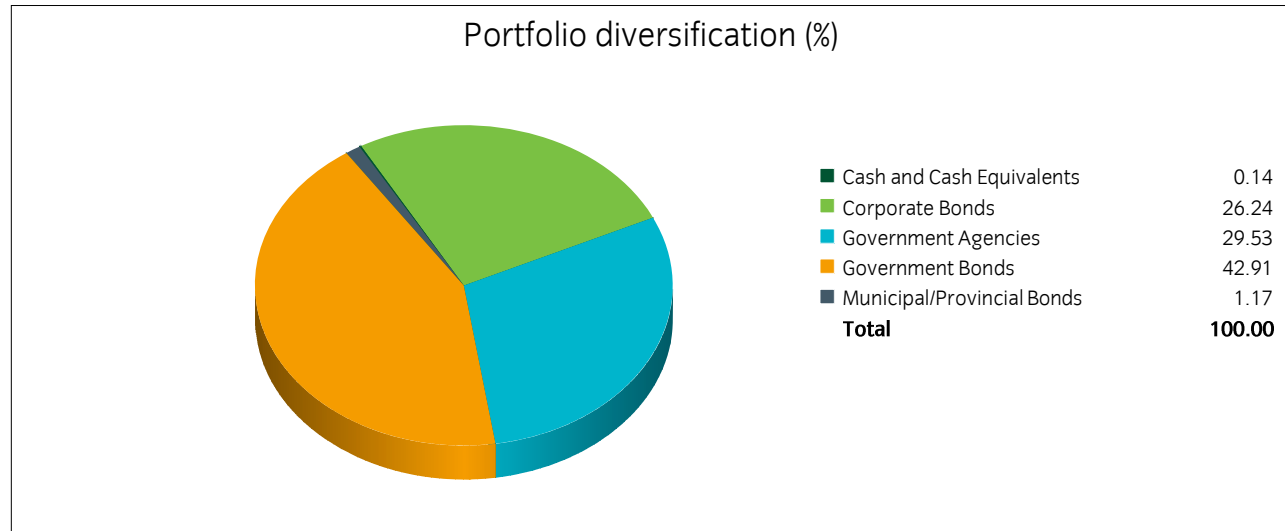

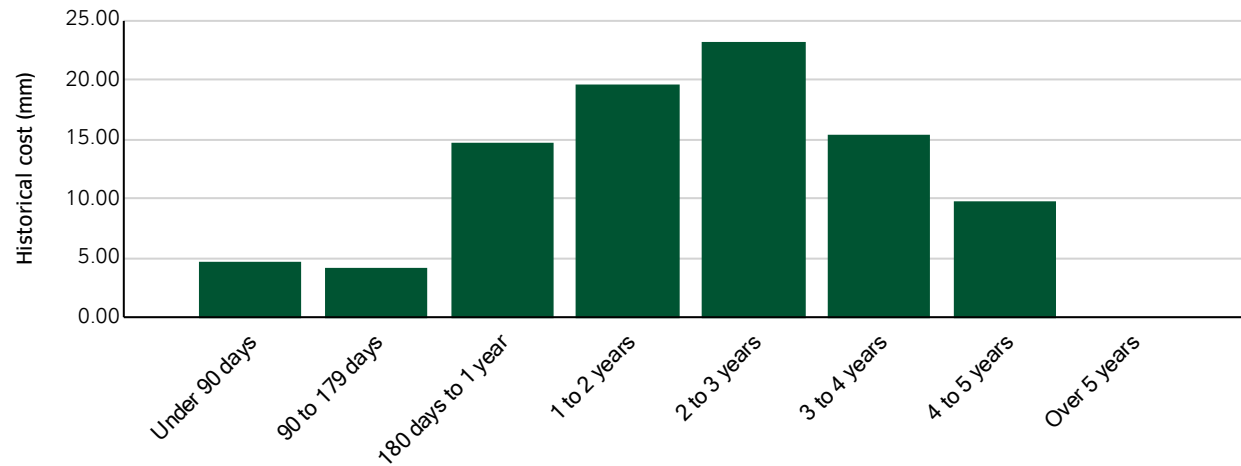
