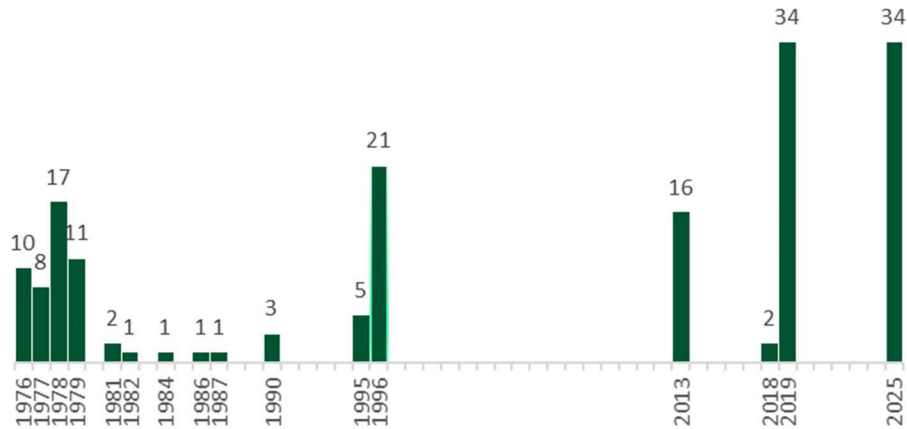

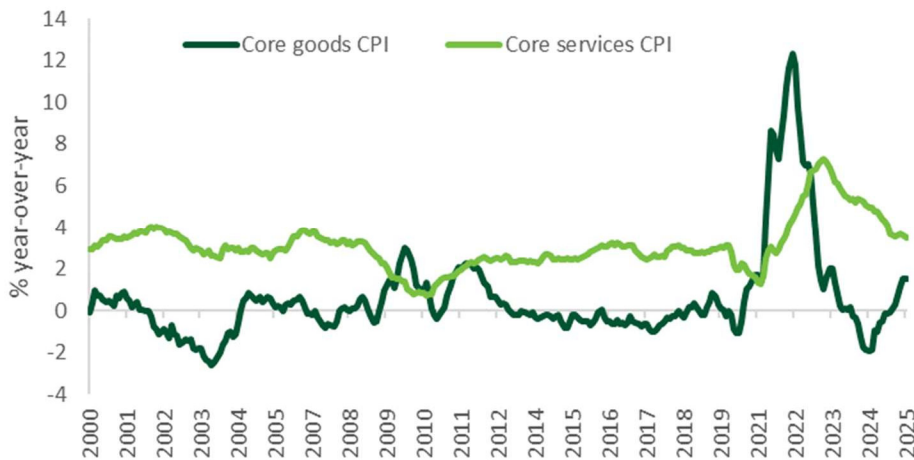

Economic Indicators and Monetary Policy

The US federal government entered a shutdown at the start of the month after Congress failed to pass the necessary appropriations bills or a continuing resolution to keep the government funded. This left federal workers unpaid. There was little progress in relieving the political deadlock to reopen the government. Democrats demanded reversals or mitigations of the administration’s Medicaid and Medicare cuts and pushed to extend enhanced subsidies for Affordable Care Act (ACA) that are set to lapse at the end of the year. Republicans demanded a passage of a short-term continuing resolution before beginning talks on ACA subsidies.

The shutdown delayed several key data releases. However, the administration made an exception for the CPI report, given the needs of the Social Security Administration to calculate the cost-of-living-adjustments for social security benefits. Headline CPI rose from 2.9% to 3% and core CPI fell from 3.1% to 3%. Both measures were lower than expected. Core goods inflation was relatively benign, albeit small tariff-impacted categories showed some significant price rises. Meanwhile, core services categories continued to ease.

Due to the government shutdown, the usual monthly jobs report was not released, however private payrolls data continued to point toward labor market moderation. US-wide initial and continuing jobless claims data was also unpublished. However, state-wide jobless claims continued to be published and indicated a general sideways trend over October.

The FOMC cut the Fed funds rate by 0.25%, once again citing labor market concerns. There were two dissenting votes, one favoring a 50bp cut and another favoring no action. Chair Powell’s prepared remarks surprised markets stating that a further cut in December was “not a foregone conclusion”. The FOMC ended its quantitative tightening (QT) program, with the intention of ensuring “ample reserves” in the banking system following some signs of frictions in money markets. Powell noted redemptions from its mortgage-backed securities will be re-invested into T-bills.

Interest Rate Summary

It was a risk-on month for assets and longer-dated Treasury yields eased. At the end of October, the 3-month US Treasury bill yielded 3.8%, the 6-month US Treasury bill yielded 3.8%, the 2-year US Treasury note yielded 3.57%, the 5-year US Treasury note yielded 3.69% and the 10-year US Treasury note yielded 4.08%.

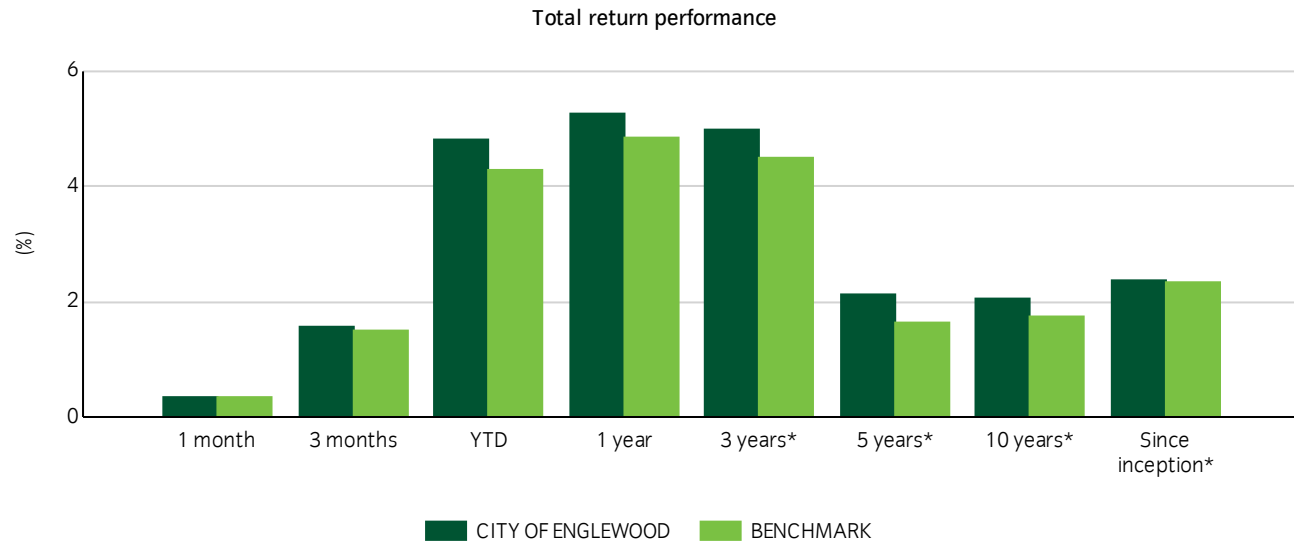

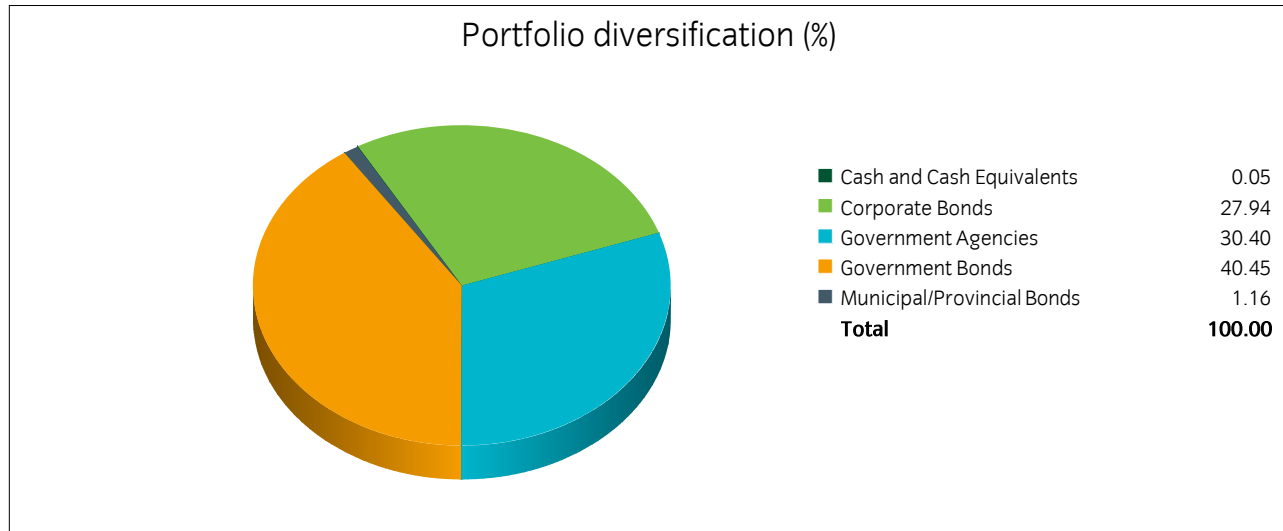

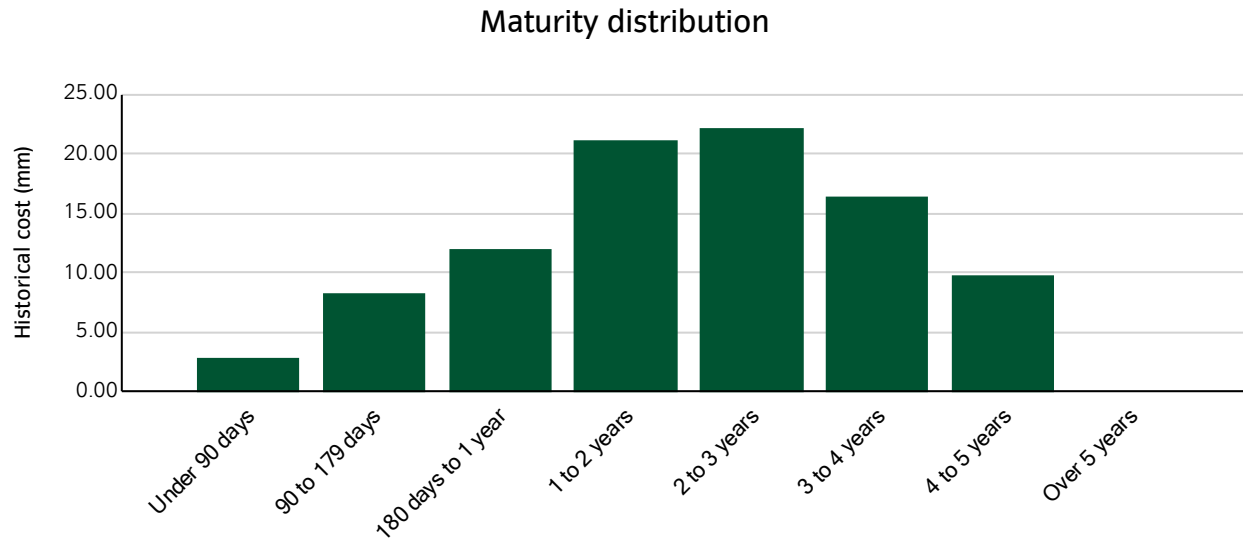
